

HARVEST KIDS NOW TERMS OF USE

These Terms and Conditions of Use (the "Terms of Use") apply to the websites, mobile applications, and software owned or operated by HARVEST BIBLE CHAPEL/HARVEST KIDS NOW, a ministry of Harvest Bible Chapel, an Illinois not-for-profit corporation. ("HKN"). HKN Sites are the property of Harvest Bible Chapel and its licensors. **BY USING AN HKN SITE, YOU AGREE TO THESE TERMS OF USE; IF YOU DO NOT AGREE, DO NOT USE ANY HKN SITE.**

Subject to your compliance with the HKN Terms of Use when you visit to the Site or use of the Service, HKN grants you a personal, non-exclusive, non-transferable, limited privilege license to enter and use the public areas of the HKN Sites. Any claim under these Terms of Use must be brought within one (1) year after the cause of action arises, or such claim or cause of action is barred. No recovery may be sought or received for damages other than out-of-pocket expenses, except that the prevailing party will be entitled to costs and attorneys' fees. In the event of any controversy or dispute between HKN and you arising out of or in connection with your use of the HKN Sites, the parties shall attempt, promptly and in good faith, to resolve any such dispute. If we are unable to resolve any such dispute within a reasonable time (not to exceed thirty (30) days), then either party may submit such controversy or dispute to mediation. If the dispute cannot be resolved through mediation, then the parties shall be free to pursue any right or remedy available to them under applicable law.

Void Where Prohibited Although the HKN Sites are accessible worldwide, not all features, products, or services discussed, referenced, provided, or offered through or on the HKN Sites are available to all persons or in all geographic locations, or appropriate or available for use outside the United States.
